INTRODUCTION:

Here’s the game plan!

The programs of the Kurt Warner First Things First Foundation are designed to share Jesus’ love and encourage others to do His work. The amazing adventure your group is about to embark on encompasses this principle. First Things First would like to provide you with an opportunity to decrease the trip costs for your group. The Foundation will provide scholarships to groups consisting of junior high, high school and college students traveling together during spring break with each group receiving **up to \$1,000** toward the cost of their service-based mission trip to benefit communities in the United States. This two-page application with requested information entered directly in this document, along with all attachments must be emailed to missionpossible@kurtwarner.org by 11:59 p.m. ET on December 1, 2018. In an effort to be responsible environmental stewards, **mailed applications will not be accepted.** All groups will be notified by email by February 1, 2019.

CRITERIA:

Who can apply?

First Things First is a non-denominational Christian-based foundation. Christian groups of any size, from any denomination and from any part of the country are welcome to apply. Groups may be formed by schools, organizations or churches and must consist of junior high, high school and/or college-age students (12-22 years old). Mission trips must be service-based (supplying both physical and spiritual needs) and benefit communities in the US.

Within six weeks of the completion of the trip, scholarship recipients will email missionpossible@kurtwarner.org with pictures and a summary of their trip. Organizations that fail to submit follow-up information will not receive consideration for future Mission: Possible! Scholarships.

Before you mail your application, make sure it's complete!

Do you match the criteria?

Group is Christian (any denomination is welcome to apply)

Applying for a group, NOT an individual (NOTE: If multiple groups from the same organization are participating in separate mission trips, each group must fill out its own complete application)

Group is traveling together (at least 50 miles) and spending the night away from home

Group is NOT traveling outside the United States

Mission trip is service-based, supplying spiritual and physical needs of God's people

Is your application complete?

ALL lines of the application are filled-in (Incomplete applications will not be considered.)

Have you included all of the attachments in your email?

Two essays from student participants

One essay from group advisor/teacher

Trip budget including a detailed breakdown of all involved costs, individual student costs, confirmed or anticipated grants and fundraising activities (See sample budget)

Formal or informal communication with organizer/work site host confirming trip details
